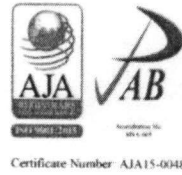

WHEREAS, Section 5, Rule 141 of the Revised Rules of Court provides that “ x x x. If the legal fees are not paid, the court may refuse to proceed with the action until they are paid and may dismiss the action or proceedings.”

WHEREFORE, RESOLVED AS IT IS HEREBY RESOLVED, that in the event the required fees and charges are not paid, the Labor Arbiter or the Commission shall refuse to proceed with the action until they are paid, and dismiss any motion or petition filed that requires payment of legal fees.
