En Banc Resolution No. 09-15
(Series of 2015)

WHEREAS, enforcement of Decisions of the Commission is effected by the Sheriffs through simultaneous service of Notice of Garnishment addressed to banks holding any deposit belonging to the respondent/s;

WHEREAS, as a result thereof, there have been reports of over garnishment which unduly prejudiced the daily business operations of respondent/s;

WHEREAS, there is a need to immediately lift the garnishment over the accounts in excess of the judgment award;

WHEREFORE, RESOLVED AS IT IS HEREBY RESOLVED, that the Sheriff is authorized to issue a Notice to Lift Garnishment¹ once an over garnishment is determined; Provided, that the accounts deposited with the banks with the least assets according to the list issued by the *Bangko Sentral ng Pilipinas*², shall be lifted first.






