WHEREAS, on 05 April 2022, a Resolution was issued by this Tribunal ordering the re-computation of complainant's awards based on the Decision of the Court of Appeals in CA G.R. No. 156151 dated 30 April 2019

WHEREAS, on 16 May 2022 the Computation and Examination Unit, NLRC, NCR, submitted a report aggregating to PhP5,842,346.15.

WHEREAS, a Motion for Execution was filed and was GRANTED.

WHEREAS, in compliance to the Memorandum of the Chairman, NLRC, dated 21 June 2016 and Memorandum of the Chairman, NLRC, dated 05 October 2018, limiting the conduct of Pre-Execution Conference.


