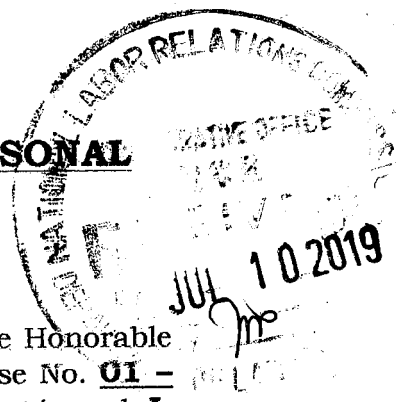

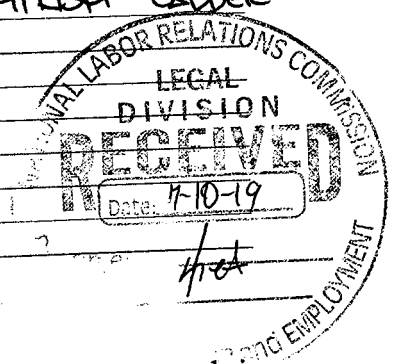


NOTICE OF LEVY/SALE ON EXECUTION OF PERSONAL PROPERTY
