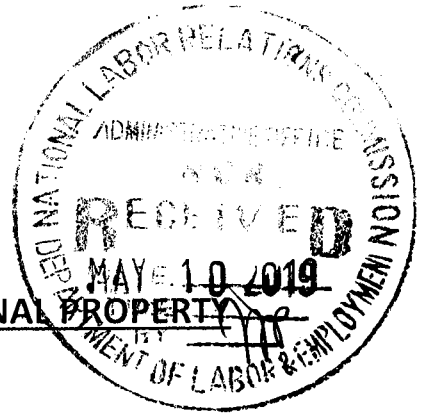

**NOTICE OF LEVY/SALE ON EXECUTION OF PERSONAL PROPERTY**


KNOW ALL MEN BY THESE PRESENTS:
