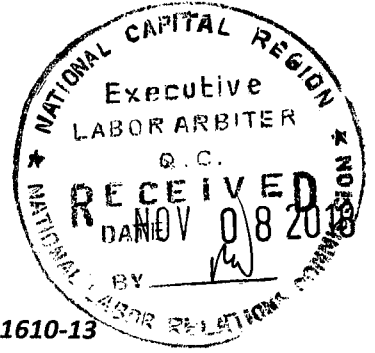

NOTICE OF LEVY/SALE ON EXECUTION OF PERSONAL PROPERTY


KNOW ALL MEN BY THESE PRESENTS:
