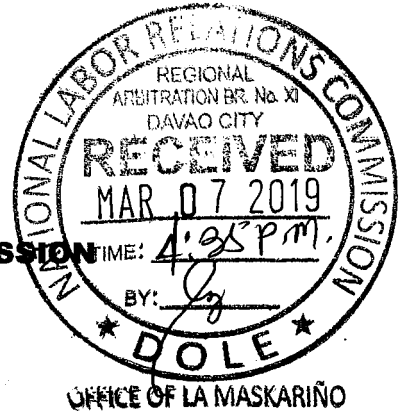

GREETINGS:

WHEREAS, on 13 June 2008, a Writ of Execution was issued in the above-entitled case for the enforcement of the judgment award due the complainants in the sum of **ONE MILLION SEVEN HUNDRED EIGHTY EIGHT THOUSAND NINE HUNDRED TWENTY NINE & 26/100 PESOS (PhP1,788,929.26)** plus the amount of **P17,389.29**, as payment of execution fee and **P8,964.64** as deposit fee due NLRC.

WHEREAS, the aforementioned Writ of Execution was partially satisfied in the sum of **Nine Hundred Ten Thousand Four Hundred Seventy Two and 12/100 Pesos (P910,472.12)**, receipt of which was acknowledged by complainants on October 23, 2018. Hence, the issuance of this updated Writ of Execution to enforce the balance of complainants' judgment award.

NOW, THEREFORE, you are hereby commanded to collect in accordance with Section 9, Rule XI of the 2012 NLRC Rules of Procedure, as amended, the total amount of **EIGHT HUNDRED SEVENTY EIGHT THOUSAND FOUR HUNDRED FIFTY SEVEN & 14./100 Pesos (P878,457.14)**, representing the balance of complainants' judgment award from respondents **SAMAL CASINO RESORT / EKLAN SERVICES, INC.**, through its **RESPONSIBLE OFFICERS** whose address on record is at Tuganga, Libertad, Kaputian, Island Garden City of Samal or wherever said respondents conduct business, **PLUS** the following fees due to NLRC: Execution Fee – **P8,520.76** and Deposit fee – **P4,392.68** pursuant to the Manual of Execution.

In case you fail to collect said amount in cash from respondents, you are further commanded to seize the movable goods or chattels of said respondents in accordance with the law, and in the absence or insufficiency thereof, out of the immovable properties of respondents, set by law, not exempt from execution.

You are hereby informed that this Writ has a lifetime of five (5) years from date and made returnable to this Office at the expiration of said period. However, you are strictly required to regularly submit progress reports or updates in connection with the implementation of this Writ.
