
WHEREAS, the retiring Commissioner is hereby required to do an inventory of their cases three (3) months prior to their retirement;



WHEREFORE, RESOLVED AS IT IS HEREBY RESOLVED, that a retiring Commissioner with thirty (30) or less pending cases, shall only be excluded from the raffling of cases two (2) months prior to the date of retirement. However, a retiring Commissioner with thirty one (31) or more pending cases is exempted from the raffle three (3) months prior to the date of his retirement.

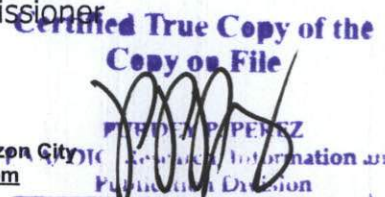
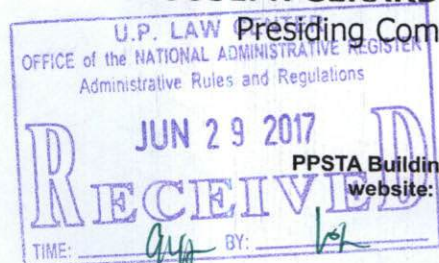


