


**WHEREAS**, to assure the uniform computation of judgment awards in Philippine peso, there is a need to set the source of the prevailing exchange rate;

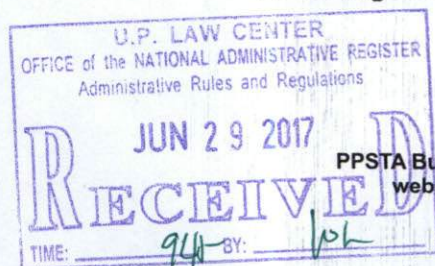

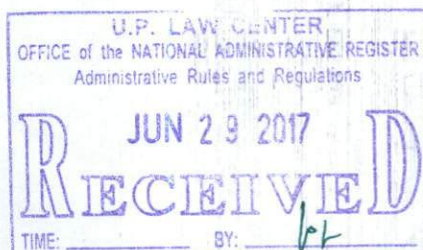
